  - For example, during pick up, drop off, and trips to the restroom.
- Making sure your child comes to camp with all check-list items from the website. There will be no sharing of food, water, sunscreen, or other supplies.
- Orca Adventures will be sanitizing surfboards and boogie boards between uses. You are encouraged to come to camp with a surf board or boogie board marked with the campers name if you have one available.

### What we are doing

- Taking temperatures of each camper at check-in.
- Sanitizing gear in between uses.
- Keeping our distance when possible.
- Giving verbal reminders about distancing when necessary.
